## Invoicing and Collection Procedures

1. Existing Homeowners – Homeowners Fee Package is mailed out 6 weeks prior to due date. Package includes: a cover letter, HOA Invoice, payment instructions, a copy of the annual budget, and a copy of this Invoicing and Collections Procedure document. Fees are due annually on March 1st. Please note that interest charges begin accumulating on overdue accounts as of March 31st of each calendar year.

New Builds – Fees are due upon closing of the real estate transaction through your lawyer. If HOA fees are not paid at time of closing through the real estate lawyer, first invoices are mailed to the property address on title. Included with the invoice is a cover letter that provides an explanation of the fees, payment instructions, a copy of the annual budget, and a copy of the invoicing and collections procedures. Fees are due upon receipt.

- 2. 30 Days after Due Date
- Interest from previous month is applied and continues to accrue on overdue accounts (18% per annum compounded monthly)
- Final Notice Package is sent to homeowner with outstanding fees due upon receipt.
- 3. 60 Days after Due Date Properties Sent to Collections
- All accounts that remain outstanding are forwarded to Field Law for Collections administration; payments are no longer accepted by CHOA. The CHOA will continue to add outstanding interest to the account. Field Law, LLP will assess their own charges to each account, verify the amount outstanding with the CHOA, collect payment and then reimburse the CHOA for amount outstanding with the

Property owners in Crestmont are responsible for all legal, collection and court costs under the terms of the Encumbrance registered on title to every property. All costs incurred by the Crestmont Homeowners' Association associated with the collection process, including legal fees and expenses, will be charged back to the homeowner. It is each homeowner's responsibility to ensure that payments are received by the Crestmont Homeowners' Association, in full, by the due dates. Interest, compounded monthly, will be applied to each account in arrears until full payment is received. Contact information for CHOA staff has been provided should there be a change in ownership information.

If for some reason you have not received or cannot find your 2019 invoice, please do not hesitate to contact Shannon Scott, Accounts Manager, at sscott@qualico.com. Payments can be made via debit, VISA, MasterCard or cheque. Payments can be made in person at the Crestmont Hall or by credit card over the telephone at 403.202.2175. Office Hours are Monday to Friday 9:30am-4:00pm (closed 12:30-1:00pm for lunch)

#### Spring Cleaning Tips



### **CALGARY – BOW NEWSLETTER MARCH 2019**

#### Happy March Calgary-Bow!

This month is typically the wettest/snowiest month of the year, but March 20 th will signify the beginning of Spring, a new season with milder temperatures and flowers on the way! I am pleased with all the work our government has done and will continue to do with Albertan's best interests always at the forefront. In February, we made history. Our government announced funding for the City of Calgary's Green Line project. This historical build will be the largest LRT project this City has ever seen. The Green Line will be the third light rail train in Calgary's transit system, adding to the existing Red and Blue lines. Commuters will be able to travel 46 kilometers across 28 stations resulting in enormous economic and environmental benefits. With increased ridership of over 60 000 commuters daily on Calgary's LRT network, the Green Line will greatly facilitate movement from one end of the City to another and create more business opportunities along this route. This new line will run from 16 th avenue north to the South East community of Seton (near the South Campus Hospital) and is scheduled to be operational (first segment) in 2026 with construction commencing in early 2020. One of the questions I often receive at my office touches on the carbon levy and its benefits to our communities and province. As many of you know, the carbon levy is part of our Alberta Climate Leadership plan. Alberta, BC and other provinces have taken steps to put a price on carbon as a key part of the government of Canada & Pan-Canadian Framework on Clean Growth and Climate Change to reduce greenhouse gas emis-

Funds from the economy wide carbon pricing are used to pay for initiatives that reduce emissions and support adaptation and transition to a lower carbon economy, including:

- Rebates for Albertans to offset cost increases
- Renewable energy projects and electricity transition supports
- Industrial and consumer energy efficiency programs
- Indigenous climate leadership initiatives
- Transit and infrastructure projects such as the Green Line project! The carbon levy rebates protect low- and middle-income Albertans who spend a higher percentage of their income on energy costs and have fewer financial resources to invest in energy efficiency products. Cancelled Projects/Programs from Cancelling the Carbon Levy would include:
- 33% Small Business Tax Reduction (\$615 million)
- Rebates (e.g. consumer rebates, greenhouses, Lloydminster) (\$1.6 billion)
- Coal Workforce Transition Fund
- RRO Price Ceiling Initiative
- Transit funding (e.g. Calgary/Edmonton LRTs, Alberta Community Transit Fund) (\$280 million)
- Coal Phase-out Agreements (\$291 million)
- Indigenous CLP programming (\$145 million)
- Energy efficiency programming (e.g. Energy Efficiency Alberta programming, Agriculture, Seniors and Housing) (\$662 million)
- Infrastructure funding (e.g. Foothills Medical Centre, UofA District Energy,

Springbank Off-Stream Reservoir, etc.)

- Renewable Electricity Program (REP)
- Transit funding (GreenTrip)
- Industrial Energy Efficiency Cost Containment funding
- Infrastructure funding (e.g. AB Community Resilience Program (ie. flood mitigation projects), Irrigation Rehabilitation Program, etc.)
- Innovation funding (e.g. Economic Development and Trade Clean Technology programming, carbon capture and storage projects, bioenergy programming, CSS Innovation

As your MLA for Calgary-Bow, I will work hard to make sure these many initiatives, programs and services continue to serve millions of Albertans. I will continue to advocate along with my colleagues to create meaningful infrastructure (Green and sustainable projects), improve healthcare and hospitals, provide schools for your children (modernizations and new builds), offer affordable daycare (\$25 pilot program), continue the school nutrition program so no child goes hungry, fight for survivors of domestic violence (my Safer Spaces Bill 204), support low-income Albertans and those with special needs/mental health support (increases to AISH and Senior's Benefits to better reflect Consumer Price Index, funding for mental health support at schools), defend jobs for Albertans (recent \$2B investment by Calgary company to upgrading facility east of Edmonton that will see 2000 new jobs, construction of a new petro-chemical company that will require 3000 positions at the peak of construction, Southwest and West Calgary Ring Roads and Green Line project that will keep thousands of Albertans working. 

#### Tree Clearing for West Calgary Ring Road

Beginning the week of January 7, 2019, Alberta Transportation will begin clearing trees and brush to prepare for West Calgary Ring Road construction this spring. This work is happening outside of the nesting window for migratory birds and other species that nest in this area.

Crews will work Monday – Saturday between the hours of 7:30 am and 6:00 pm. The work is expected to be complete by the end of February 2019.

#### Is Your Community Prepared?

Calgary Emergency Management Agency wherever you live and work, you should be informed about the hazards that can lead to an emergency or disaster. In Calgary, we face a number of hazards. Many of them are weather – related, including severe winter storms, thunderstorms, hail, tornadoes, windstorms, or floods. Other hazards include utility outages (electricity, gas, phone, network), hazardous materials release (such as sour gas incidents), civil unrest and pandemics. Some neighbourhoods may be more vulnerable than others for a particular hazard, which is why it is so important to know the risks that you may face. There are many things that can be done to help prepare for an emergency or disaster. As a community resident, you can prepare yourself and your family, and work with your neighbours to ensure that you are better prepared and better able to withstand a disaster.

#### Here's what can be done:

- 1. Be prepared personally The basic steps for personal and family preparedness are: knowing the risks, making a family plan, and getting a 72 hour preparedness kit (for more information on these kids visit Calgary.ca/cema
- 2. Stay Informed There are many ways through which local authorities like CEMA, the Calgary Police Service and Calgary Fire Department communicate with citizens to warn of dangers and give instruction about what actions to take, visit emergencyalerta.alberta.ca for more information.
- 3. Know the risks in your home and mitigate hazards Some things you can do are: ensure adequate insurance coverage, keep your home (including all appliances) in good working order, check smoke alarms, carbon monoxide alarms and fire extinguishers regularly, and know where utility or appliance shut-off valves are and how to use them
- 4. Know your neighbours Have a buddy system, or "adopt" a neighbour. If an emergency or disaster is imminent or occurring, check with them to make sure they are okay. Alert emergency medical personnel if you have not been able to contract your buddy. It is also helpful to know what resources your neighbours might have.
- 5. Help each other be prepared If you and your neighbours are prepared and able to take care of yourselves and your

- families, first responders can concentrate on those who need assistance most. You can encourage your neighbours by sharing this information with them.
- 6. Get First Aid certified take a First Aid and CPR course so you know what to do in the event of an emergency.
- 7. Know the hazards and risks in your neighbourhood These can include proximity to major transportation corridors, industrial centers, gas or oil wells and pipelines. Knowing all the risks (general and specific to your neighbourhood) will help you be better prepared.
- 8. Know evacuation routes in your neighbourhood Evacuations are very disruptive, but it is very important to evacuate if you are told to do so. Knowing all the ways out of your neighbourhood can help prevent congestion at common exit locations.
- 9. If you live in a condominium or apartment, know who your condo board representatives and property manager are, and know how to reach them –Knowing the responsibilities of the condominium board, building owners, and property managers can save valuable time and stress. Check if your building or complex has an emergency response plan. If they do, you should familiarize yourself with them and encourage your neighbours to do so also.
- 10. Make a plan Not all emergencies or disasters occur while you are at home. Your place of employment should have emergency plans as well. Also consider having a 72-hour kit at work as well in the event that you are unable to return home. Have your families contact information written down and accessible and have an out of town contact where all family members can "check in". Ensure you know how your child's school or daycare will deal with an emergency or disaster as well.
- 11. Check your insurance policy Insurance policies can vary considerably as to what may be covered and what isn't. You should review your policy on a regular basis. Make sure to understand your policy and if you have questions, contact your representative or broker.
