SPRAY PARK OPENING

Spray Park Opening June 1, 2017 We anticipate opening on schedule this year, however complications can arise after being shut down for the season. Please keep an eve on our website for regular updates regarding opening! Care and maintenance of the Crestmont Residents' Hall Spray Park falls under the regulation of Pool Standards, 2014 for the Swimming Pool, Wading Pool and Water Spray Park Regulation. We are often asked why the spray park is occasionally shut down without any warning, this is due to contamination and the water quality response plan has been enacted. Food, chemicals, blood, fecal matter and vomitus foul the water. Sources of this contamination include the people using the facilities and animals that come in contact with the water. While residents are aware that dogs are not permitted to enter the park, contamination by wild animals such as birds is considerably more difficult to enforce and the water is an enticing bird bath to say the least. Microbiological sampling is taken on a daily basis and fecal coliform contamination is the most common issue facing the spray park.



With your help we can manage contamination and prevent unnecessary shut downs:

- 1. Dogs are not permitted on the premises, with the exception of seeing eye dogs or other animal used to assist persons with disabilities (these animals may not enter the water under any circumstances);
- 2. Bicycles and roller blades are not permitted through the fountains;
- 3. Street shoes should never be worn in the water;
- 4. Any person with diarrhea or a history of diarrhea over the previous 2 weeks must not enter the water;
- 5. Young children, 35 months and under, and anyone who is incontinent must wear protective, water-resistant swimwear in order to minimize the introduction of contamination;

6. Please keep small toys and water balloons out of the spray park as they plug the filtration system and cause serious damage The following response plan is in place to manage contamination when it occurs: The most common disinfectant treatment method for contamination is chlorination. If low volume pools such as a whirlpools, teach pools, wading pools and spray parks are contaminated with fecal matter or vomitus, it must be removed, drained and the cistern cleaned and disinfected. After cleaning, the cistern is disinfected with chlorine, refilled and shock treated. This process can take as long as 2 days, weather permitting. Therefore, the spray park is closed until the water is safe again to use. Thank you for your patience when this occurs.

RESPONSIBLE PET OWNERSHIP IN PARKS

As we all enjoy being outside and spending time with our family, friends and pets; we want to ensure we are creating as safe place for all our neighbours. Knowing and adhering to the regulations in the Responsible Pet Ownership Bylaw 23M2006 helps to ensure that dogs are not being a nuisance in the community and dogs and citizens are safe. City of Calgary would like to remind dog owners of the following:

- When off of their owner's property, dogs must be on a leash unless in a designated off- leash area.
- When in designated off-leash areas, dog owners must ensure their dog is under control,
 is within their sight and responds to commands
- Parking lots adjacent to off-leash areas are on leash.
- •Owners are responsible for picking up all waste produced by their dog.
- Dogs are not allowed in school grounds, playgrounds, sport fields, golf courses, cemeteries, wading and swimming areas, and other areas prohibited by signs.
- Dogs must be walked on the right hand side of the pathway on a leash that is no more than two metres in length and must not interfere with other pathway users.
- •Owners cannot cycle, in-line skate or skateboard on a pathway with a leashed dog.
- Dogs must not enter or swim in any body of water within a park except a river that runs through, or is adjacent to, a City park
- Have and wear a City of Calgary licence when the dog is three-months- old



Project History

In 2016, The City had discussions with the community about removal of accumulated sediment from the Crestmont Stormwater Pond. In October 2017, The City began work to remove sediment from the pond. The sediment removal was completed in February 2018. This spring, The City will repair the area that was used as a haul road and restore the pond's north bank.

Project Benefits

The removal of debris and sediment from the Crestmont Stormwater Pond reduced environmental impacts downstream, improved the pond's health and restored its storage capacity which decreases the risks of overland flooding during storm events. We removed 11,638 cubic metres of sediment from the stormwater pond. That's more than 23 million kg.

Project Timeline

In May, The City will restore the north bank of the Crestmont stormwater pond including the area that was used as a temporary haul road.

Project Details

Restoration work will include:

- Re-grading and placement of new topsoil
- Re-seeding the area with a native seed mix
 Re-planting previously removed bushes and plants
- Levelling and seeding the foot path along the north side of the pond

Construction impacts

Restoration work will occur at the north-west edge of the community centre parking lot and along the north side of th pond. Construction fence will remain on the site until the Crestmont pond is filled with water to its normal elevation ϵ the restoration work is completed.

Where there's water, there's risk. The importance of safety on all of Calgary's waterways cannot be understated. To help everyone reduce their risk while enjoying the water, we have compiled what you will need to navigate The City's waterways.

Life jackets are required Even strong swimmers in shallow, slowmoving water are required to wear lifejackets or personal flotation devices (PFD). Lifejackets are sold at most sports and general goods stores and several local vendors rent them for day use. Before using your life jacket or PFD, make sure to:

- Check the size and weight restrictions
- Start with the buckles and straps loose then fasten them from the bottom of the jacket to the top to ensure a snug fit
- Once fastened, test the lifejacket or PFD by holding your arms over your head and asking someone nearby to grab the tops of the arm openings and gently pull. Make sure there is no

extra room above the arm openings and that the jacket does not ride up over your face or chin. Remember, there is a mandatory court appearance and up to \$500 fine for not wearing a life

jacket or PFD on Calgary's waterways. Keep kids safe around water Remember to always keep toddlers or young children within arm's reach while in or around all bodies of water. This applies to rivers, lakes and backyard bodies of water like ponds and pools. Lifejackets are critical for children and inexperienced swimmers. Encourage children to learn to swim and what to do in an emergency on the water. Bring the right suppliesMake sure you have the following before heading out:

- Watercraft suitable for the body of water and conditions.
- Properly fitting life jackets for everyone on



- Water, hats and sunscreen to stay hydrated and comfortable.
- Cell phone to call for help in case of emergency.
- A complete water safety kit to have in your watercraft.

What's in a safety kit?

- A bailing device to remove water from inside the watercraft. A hand-held bailer can be purchased or made by cutting the end of a bleach bottle.
- A paddle or oar to help you control your craft.
- A sound-signaling device to help with navigation, alerting others of your approach, or in case of emergency. This could be a portable air horn, whistle, mechanical whistle or bell.
- A heaving rope or towing line (15 metres long) that floats to use for rescue or to pull your craft to safety.
- Navigation or safety light to be used at night or in poor visibility. Safety kits are required on all types of non-powered watercraft including kayaks, canoes, dinghies, inner tubes and rafts. Before going on the water Always SCOUT, ASSESS and DECIDE from shore before going on rivers, lakes and waterways.
- 1. Scout the river for potential hazards and check the weather and water conditions.
- 2. Assess the level of danger. Check for river advisories and assess the swimming and paddling skills of your crew.
- 3. Decide if it is safe to raft or boat. 3. Decide if it is safe to raft or boat.

YOU AND YOUR CITY

Hello Calgary Bow,

We are nearly half way through this legislative session. I continue my work in Edmonton, as an advocate for the communities of Calgary-Bow until early June. Calgary Bow is an active community, with a strong sense of community in all of our neighbourhoods. We have exceptional community engagement and a lot of hard working volunteers that organize events that make it a fun place to live. I encourage you to check out your community calendars for upcoming events. If you have some spare time or an interest in organizing an event, reach out to your local community association and volunteer. I know that we have a lot of families in Calgary Bow, that's why I was pleased to see education emphasized in the 2018 budget. Enrollment growth in the K-12 education system has been fully funded, as we are expecting 15,000 new students to enroll in the coming year. Last year, our government removed the burden of Instructional Supplies and Material Fees (ISM Fees) from the family budget, this continues through the Ministry of Education budget for 2018. Post-secondary students can look ahead with confidence, knowing that the tuition freezes for post-secondary education have been extended for a fourth year. We've also invested in 3,000 new technology spaces and scholarships for technology and other emerging sectors have been made available. The Alberta College of Art (ACAD) has been awarded university status to better reflect its existing degree offerings. This change in designation reflects the school's role as the primary fine arts institution in Alberta. The request for the change in designation was brought forward by ACAD. The introduction of \$25/day childcare was well received across the province. This program is being expended by creating an additional 4,500 affordable child care spaces to help working parents. The School Nutrition Program, which was first piloted right here in Calgary-Bow has also proven successful. Improved attendance, decreases in negative student behavior and an increased sense of community and belonging are just some of the observations provided by the participating school boards. I am very pleased to see this program being expanded across the province. This year, \$328 million will be distributed to family budgets across the province through the Alberta Child Care Benefit and the Alberta Family Employment Tax Credits. Hello Calgary - Bow,

The Spring Legislative Session is wrapping up and I am looking forward to returning to help out all of our local community events. If you are new to the community, be sure to check out your community association website and local newspapers like this one for event calendars and opportunities to get involved. The Government of Alberta has been working hard to make life better for communities of Calgary-Bow, and for all Albertans. On the face of ongoing challenges threatening the construction of increased pipeline capacity, I am proud that our government is acting to defend the energy industry. Historically, the US was the biggest market for Alberta energy. Today, they are also our biggest competitor. The result is that we are selling our resources for less than they are worth and we need access to new markets overseas. We need the Trans Mountain pipeline expansion. But roadblocks put in place by the BC government have caused uncertainty and hurt investors' confidence, resulting in pipeline delays and the loss of millions of dollars in revenue to the Canadian economy. The delays are impacting the hundreds of thousands of jobs that help put food on the table and roofs over the heads of families not just in Alberta, but across Canada. That Revenue could also be used to build roads, schools and hospitals. Here are a few facts about current exports in Alberta/Western Canada

- 7.2 billion cubic feet per day in 2017 of natural gas (from Alberta)
- 4.1 million parreis a day of crude oil (from western Canada)
- 200,000 barrels a day of refined fuels (gasoline, diesel, jet fuel)
- *Alberta number based on internal government estimates, includes all methods of transportation During this legislative session the Government of Alberta has introduced two important pieces of legislation to protect Alberta's interests and get more value from our natural resources. Bill 12: Preserving Canada's Economic Prosperity Act would give the government authority to, if necessary, require any company exporting energy products from Alberta to obtain a Licence. These products include natural gas, crude oil and refined fuels like gasoline, diesel and jet fuel. Export restrictions could be imposed on pipelines, as well as transport via rail or truck. Companies would not be automatically required to apply for an export licence and would only be directed to do so if the minister deemed it necessary. One reason that the minister could give for requiring a license is whether adequate pipeline capacity exists to maximize the return on these resources produced in Alberta.


Bill 12 gives the government a toll that we don't currently have. We don't want to use it be we will do whatever is necessary to get this pipeline built. Bill 1: The Energy Diversification Act builds upon Alberta's traditional strengths. It moves us away from the boom and bust policies of the past without sacrificing our leadership in oil and gas. Developing our raw resources into higher-value products before exporting them makes good economic sense. Renewal of the Petrochemical Diversification Program will build on the successful first round, which awarded support two projects expected to create more than 4,000 construction jobs and over 200 full-time jobs during operation. We are also providing incentives for more partial upgrading of bitumen and building more feedstock infrastructure. THE CITY OF CALGARY – PREPARING FOR FLOOD SEASON

With a higher-than-average snowpack, overland flooding affecting several Alberta communities and the five-year anniversary of the 2013 Southern Alberta flood, we know that river flooding is top-of-mind for Calgarians. It is our priority at the City of Calgary to monitor, manage and reduce flood risk, and to ensure citizens understand their risk and have the resources available to prepare. River flooding impacts all Calgarians who live, work, commute or recreate in the city centre or along the Bow and Elbow Rivers. River flooding is most likely to occur between May 15 and July 15. We actively monitor river, weather and snow pack conditions to prepare for potential flooding. It is important to note that:

- Heavy rainfall upstream of Calgary has the biggest influence on river flood risk. These events are challenging to forecast because we are so close to the mountains. We can sometimes see potential rain events 5 to 7 days ahead, but by the time we know how high river flows may be, we may have less than 24 hours to respond appropriately.
- A high snowpack alone can cause high flows, but does not cause our rivers to flood. The snowpack in the mountains has been higher than average this year, however, lower spring temperatures in the mountains means the snow is melting slower than on the prairies, where snowmelt is causing flooding in other municipalities.
- The City and Province continuously monitor for conditions that can develop into flood events. Since 2013, together with the Province, we have committed more than \$150 million towards projects that will reduce our risk of river flood damage. We have also strengthened our understanding of the flow of the Bow and Elbow Rivers, how rivers change, flood modelling, forecasting, preparedness and response. While we are working to reduce our risk of river flood damage, we cannot eliminate the risk of flooding entirely. Citizens have a critical role to play in preparing for river flooding.







The Crestmont Homeowners' Association Annual Revenue Breakdown:




2017 TOTAL REVENUES = \$301,300
