Interest Free Period Ends June 30th 2016

Please be advised that the six month interest free period for the Crestmont Homeowners' Association fee ends June 30th. Annual HOA fees are mandatory for all homeowners in Crestmont and are a registered encumbrance on your property title.

The HOA invoice is due upon receipt in January and interest begins accruing on overdue accounts as of July 1st each year.

Important Changes to Fee Collection

January Invoices are sent out to homeowners'

and are due upon receipt.

A letter will be sent out to all homeowner's July 1

with outstanding accounts to notify them

that payment is past due.

Outstanding invoices will be sent to August 1

residents with accrued interest.

List of unpaid properties will be sent to September 1

Field Law for Collections.

1st Stage Collections: Demand Letters will September 15

> be sent to each homeowner outlining responsibilities pursuant to filed encumbrance on title and demanding payment and collections costs to be paid within 30 days. All legal costs and interest to be paid by the homeowner as outlined in

the encumbrance.

October 15 2nd Stage Collections: Letters are prepared

and sent to the mortgage company registered on title advising that the homeowner is in breach of mortgage covenants and asking the mortgage

company to pay the HOA arrears and legal/ collection costs.

November 15 A Civil Claim is prepared and filed.

*Please note that all outstanding invoices will be subject to 18% interest per annum under the encumbrance with interest accruing until payment has been collected.

If you have not paid your annual fee yet, please make sure you do so right away to avoid unnecessary interest charges. If for some reason you have not received or cannot find your 2016 invoice, please do not hesitate to contact Shannon Scott, Accounts Manager, at <code>sscott@qualico.com</code>.

Spray Park Opening is Anticipated Early June!

Due to recent updates to our security system, resident care and maintenance of the Crestmont Residents' Hall Spray Park falls under the regulation of Pool Standards, 2014 for the Swimming Pool, Wading Pool and Water Spray Park Regulation. We are often asked why the spray park is occasionally shut down without any warning; this is due to contamination and the water quality response plan has been enacted. Food, chemicals, blood, fecal matter and vomitus foul the water. Sources of this contamination include the people using the facilities and

animals that come in contact with the water. While residents are aware that dogs are not permitted to enter the park, contamination by wild animals such as birds is considerably more difficult to enforce and the water is an enticing bird bath to say the least. Microbiological sampling is taken on a daily basis and fecal coliform contamination is the most common issue facing the spray park.



With your help we can manage contamination and prevent unnecessary shut downs:

- 1. Dogs are not permitted on the premises, with the exception of seeing eye dogs or other animal used to assist persons with disabilities (these animals may not enter the water under any circumstances);
- 2. Bicycles and roller blades are not permitted through the fountains;
- 3. Street shoes should never be worn in the water;

- 4. Any person with diarrhea or a history of diarrhea over the previous 2 weeks must not enter the water;
- 5. Young children, 35 months and under, and anyone who is incontinent must wear protective, water-resistant swimwear in order to minimize the introduction of contamination;
- 6. Please keep small toys and water balloons out of the spray park as they plug the filtration system and cause serious damage.

The following response plan is in place to manage contamination when it occurs:

The most common disinfectant treatment method for contamination is chlorination. If low volume pools such as a whirlpools, teach pools, wading pools and spray parks are contaminated with fecal matter or vomitus, it must be removed, drained and the cistern cleaned and disinfected. After cleaning, the cistern is disinfected with chlorine, refilled and shock treated. This process can take as long as 2 days, weather permitting. Therefore, the spray park is closed until the water is safe again to use. Thank you for your patience when this occurs.

The HOA will make every effort to insure the spray park is used only by Crestmont residents whose accounts are in good standing. The Crestmont Homeowners' Association has hired a Park Monitor to oversee the spray park and tot lot. The Park Monitor will be responsible for:

- General upkeep of the water spray park and tot lot.
- Ensure the facilities are used exclusively by Crestmont residents and keep attendance records.
- Maintain a clean, safe and pleasant environment.
- · Act as a goodwill ambassador for park visitors.
- Program and occasionally conduct games to attract and entertain users.

Highlights:

- It was pleasing to hear that 86% of residents attended the Crestmont HOA Stampede Breakfast in 2015.

Waste and Recycling Changes

New bylaw changes will require all businesses and organizations in Calgary to recycle a specific list of materials starting November 1, 2016. The Crestmont Residents' Hall will be required to provide adequate storage and containers for a specific list of materials and there will be fines if we do not comply.

As of February 1, 2016, commercial vehicle loads will have higher fines for loads containing recyclable materials. Waste disposal fees at the Hall have already seen an increase reflecting this change. We are currently investigating waste and recycling options and looking to implement changes prior to the November deadline in order to see a change in our fees.

Council has also approved an Organics Diversion Strategy and the proposed bylaw amendments will be brought to council this Fall.

Changes at the Residents' Hall directly related to the new bylaws will include new waste and recycling containers, both inside and out. We will also have new waste and recycling bins in our parking lot, which will require a new or additional enclosure. There will be a policy implemented that will require our current and future tenants to follow the new waste and recycling guidelines.

Crestmont Residents Hall Access Card

Every homeowner should have at least one access card, which allows you to enter into the lower level of the Hall to use the facilities. If you have lost your access card or require additional cards, please stop by the Hall during office hours to set-up a new access card. There is a \$10.00 fee for replacement or additional Hall Access Cards.

Hall Updates

We have been very busy at the Crestmont Hall working on several improvements. New flooring was installed April 1, 2016. The new floors were purchased and installed by Divine Flooring. They are a vinyl plank and are "virtually indestructible" with a commercial warranty of 15 years.

Minor improvements keep the Hall looking fresh, clean and desirable to potential renters. We have recently:

- Cleaned all of the light fixtures and replaced with LED bulbs.
- Removed old white 3M hooks for hanging decorations and replacing with black metal hooks.
- Electrical outlets were all replaced with new white receptacles.
- Tile flooring in the main entrance and bathrooms was deep cleaned.
- · Replaced front entry way rug.
- · Banquet chairs steam cleaned
- Lines painted in the parking lot.
- Storm pond fountain was installed April 8.
- Spring landscaping cleanup was done and irrigation has been started.



Our Councillor Report

Carbon Tax on the tax?

The Provincial Government has announced a carbon tax that will come into effect in 2017. There will be a carbon tax on your home heating bills and your transportation bills. Unfortunately, this same tax will apply to the City's transit, police, and fire departments. This tax will add \$6M to the operating budget.

This may affect Calgary Transit's service hours, which are already stretched thin due to decreased ridership. Other options may be to increase transit fare or add ½% to Calgarians' property taxes. The City is already undertaking measures to help reduce its carbon footprint. We have a CTrain line that's fully powered by wind-generated electricity. Since 2013, The City has been investing in greener buses. The Calgary Police has issued an idle-free campaign.

Provincial Property Tax

On your upcoming property tax bill, there are two

components noted – the City's portion and the Province's portion. City Council has decreased its property tax hike from 4.7% to 3.5% this year. I will be advocating for zero hikes in 2017/2018. The Province has issued a 10.2% increase in its education/property tax. We were expecting an increase under the current economic environment, but certainly not as extreme a one. Unfortunately, this means that when the property tax hikes from the City and the Province are combined, homeowners face a total tax hike of 6.1%, which equals about \$170 in 2016 instead of \$60. I can appreciate the difficult times many Calgarians are experiencing, and truly believe we have a responsibility to respond by lowering taxes. As The City we do not run an operating deficit and nor should we. You have my continued commitment to challenge administration and advocate prudent financial governance.

More RV Parking

The traffic bylaw prohibits an RV from being parked on the street next to the owner or operator's residence for more than 48 hours.

The Land Use Bylaw states:

- (1) A recreational vehicle must not be in a front area for more than 24 hours.
- (2) A trailer for transport can be in a front area, only while loading or unloading.

Since, many use their RVs during the summer, these bylaws could be very restrictive for RV operators.

- How can these bylaws be changed to allow for more flexible parking for RVs at the operator's residence (e.g. on a driveway) from May until September?
- How many complaints are there for RV parking issues through 311? How many of these relate to RVs parked on streets, and how many relate to RVs parked on private property?

City staff were asked to follow up with answers and report to City Council.

Street Cleaning Challenges

During street cleaning, some community residents face unique challenges. They have laneless



parcels and there was no requirement to put in front driveways. The City's notice is that they must remove their vehicles within 2-3 days. This is a problem for people to know when they can and cannot park their vehicles on the street and they may not have any alternatives. These residents have to move their vehicles completely offsite for street cleaning. Are there ways of having a ticket withdrawn once issued, since they do not have onsite parking?

The Acting General Manager of Transportation reported that spring cleaning went quickly and very well, as the City started earlier due to the weather. He acknowledged the special circumstances and suggested a meeting with the Director of Roads, community representatives, and Councillor, in order to help find solutions.
